1. his Invitation for Tenders follows the General Procurement Notice for this Project which appeared in Tanzania Procurement Journal and Daily News dated 11<sup>th</sup> and 12<sup>th</sup> October, 2017.
2. The Government of Tanzania has set aside funds for the operation of the National Food Reserve Agency during the financial year 2017/2018. It is intended that part of the proceeds of the fund will be used to cover eligible payment under framework contract for the **transportation of Maize grain from and to various NFRA Warehouses.**
3. The National Food Reserve Agency now invites sealed Tenders from eligible and qualified Tenderers for the transportation of Maize grain from and to various NFRA Warehouses under Framework Contract. As indicated in the activity schedule.

Tendering will be conducted through the **National Competitive Tendering** procedures specified in the Public Procurement (Regulations, 2013 – Government Notice No. 446 which read as one with Public Procurement (Regulation Amendment of 2016 – Government Notice No. 333) and is open to all Tenderers as defined in the Regulations.
5. Interested eligible Tenderer may obtain further information from and inspect the Tendering Documents at the office of the Secretary, National Food Reserve Agency Tender Board, P.O.BOX 1050, Kizota, Industrial area from 7:30 am to 3:30 pm on Mondays to Fridays inclusive except on Public Holidays.

A complete set of Tendering Documents in English and additional sets may be provided to the Tenderers on the submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of 100,000 (**Tanzanian Shillings One hundred thousand only**). Payment should be by Cash, payable to Chief Executive Officer P.O. Box 1050, Dodoma.
7. All Tenders must be accompanied by a **Bid Securing Declaration** in an acceptable format.

All Tenders in one original plus two copies, properly filled in, and enclosed in plain envelopes must be delivered to the address below: **The Secretary, National Food Reserve Agency Tender Board, P.O. Box 1050, Dodoma.**
9. Late Tenders, portion of Tenders, electronic Tenders, Tenders not received, and not opened and not read out in public at the Tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
